About the Portal

The Australian Energy Regulator (AER) has developed the **Energy Innovation Toolkit Portal** (the **Portal**) to provide a streamlined process for users of the Energy Innovation Toolkit (the **Toolkit**) to:

- seek informal guidance from the **Innovation Enquiry Service (IES)**, or
- apply for **trials** (including presently trial waivers, and soon also trial rule changes) offering regulatory relief, facilitated through waivers issued by the AER and the Essential Services Commission (ESC), or rule changes administered by the Australian Energy Market Commission (AEMC).

The Portal allows you to lodge and manage your questions and applications in a central case-management system, enabling Toolkit Project Partners (the AER, AEMC, ESC and the Australian Energy Market Operator) to collaborate in assessing your applications and providing responses to your queries.¹

This Guide is for users who have already accessed the EIT website and want to find out more about how the process of applying for a trial or seeking a response to an IES enquiry will work. In this Guide, we provide information on how to use the Portal, what sort of information can assist your application, and how we will respond to your enquiry or application.

Who is the Portal for?

The Portal is for people intending to apply to the Toolkit for either:

- (a) informal guidance through the IES
- (b) a trial waiver from the Australian Energy Regulator or the ESC, or
- (c) a trial rule change from the AEMC.

More information about each of these applications, including what can and cannot be applied for, is [available on the website](#).³

¹ Note: while the Australian Renewable Energy Agency (ARENA) is a Toolkit Project Partner, ARENA will not have a role in the assessment or monitoring of trial projects, and will not have access to the Energy Innovation Toolkit Portal. Instead, ARENA will direct innovators to the Energy Innovation Toolkit to ensure that their projects are supported with regulatory guidance and, where appropriate, trials.





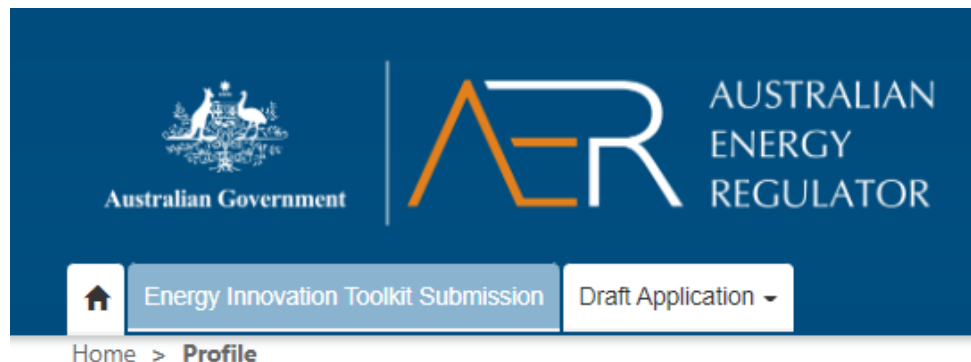

How to apply

First, click on the Energy Innovation Toolkit Submission tab.



This page contains some scoping information about the services offered, and allows users to view a list of their applications (once made).

The Portal will eventually accept applications for:

- (a) informal guidance through the Innovation Enquiry Service (IES)
- (b) a trial waiver from the Australian Energy Regulator (AER) or the Essential Services Commission (ESC), or
- (c) a trial rule change from the Australian Energy Market Commission (AEMC).

Presently, applications can be made for the IES, and for trial waivers from the ESC.

Regulatory Sandboxing legislation enabling the AER to accept trial waiver applications, and the AEMC to accept trial rule changes **has not yet come into effect**. When Regulatory Sandboxing legislation comes into effect, this Guide will be updated with details on how to submit applications through the Portal for these forms of regulatory relief.

Important Note: Applications forms will time out if no action is recorded for 15 minutes. As you move through the form, the data you have entered on previous pages is saved, but if you do not proceed to the next page data on your current page may be lost if the page times out. To prevent data loss, ensure you remain active or move to the next page to save your work. Should you need to exit the form at any time, you can click on the “Energy Innovation Toolkit Submission” tab at the top of the screen. You will be able to return to your draft form by clicking on the “Draft” item shown on this page at a later time. Please note that draft applications are automatically removed from the system after 30 days if they are not actioned.

Once you click “Next Page” you will be taken to the “Enquiry Specifics” page. The enquiry specifics page is where you will be asked what your specific enquiry is, as well as some other information which will assist us in responding to it.

Enquiry Specifics – What to include and not to include

On this page you will be asked to respond to four questions.

- 1) The first relates to **your project or business model**, specifically “Please provide a summary in a few sentences of your innovative product, service, approach or business model. Please provide enough context of your project to assist AER in providing you with a response.”
 - a) We are looking for information about your business or the product/service you are intending to launch. We appreciate any information that will help us to understand how you will run your proposal, and how it will be experienced by end-users. It is also helpful to explain here the project stage you are currently in. Here is an example of an ideal response about a hypothetical company:

I work for Example Company, a new start-up solar company operating in Victoria. We have recently secured funding to purchase land and develop a new form of solar farm outside of Small Town and have already begun development of this 2MW facility (having obtained the relevant development approvals from our local council). Our business model is designed to address a need in Small Town for cheap and clean electricity. We will be selling electricity at up to 30c/MWh cheaper than the market rate by utilising our efficient, newly patented Super Solar technology to generate electricity with 15% less energy loss This is done by [information relating to the technology]. A group of residents in Small Town have joined together to purchase a community battery and are looking to charge this battery at times where costs are low to offset their usage during peak times on the network. We are looking to sell directly from the solar farm to this battery so that the residents can benefit from our cheap, clean and local electricity, without having to subsidise expensive network costs in our isolated town. We are proposing to enter into a Power Purchase Agreement with these residents, and also to offer electricity supply to other residents of Small Town. We are also considering expanding our business in the future (depending on how the roll-out goes) to supplying smaller batteries to individual households to maximise the benefits of cheap off-peak solar generated at our farm. We will be offering “rent to buy” and “buy outright” options for these batteries.

- b) This example is ideal in form as it sets out:
 - i) the nature of the business and products (both present and future)
 - ii) what approvals have already been sought and what action has already been taken
 - iii) the intended customer base and how it will address their needs
 - iv) the context in which it will be operating.
 - c) The applicant in this hypothetical example may wish to note that the information relating to the “New Technology” technical specifications is confidential, and information is provided below about the proper way in which to note this.
 - d) It is important to note that the example used above is only reflective of one example of the many kinds of enquiries we anticipate we will receive. If your scenario does not resemble the above example this is not an issue and we look forward to hearing from a variety of innovators, community organisations and other entities about your new ideas and services.

- i) While it's helpful to include the information listed in (b), it's okay if you don't know all the answers and if your project is not as developed as the example enquiry above. The IES can also provide feedback on more general regulatory questions, to help orient your thinking.
 - e) At this stage feel free to provide us with any detail you feel is necessary to understand your proposal, but please note that a character limit of 5,000 is in place in each box as we are unable to consider vast quantities of information. Should you need to refer to **limited** additional resources, you are able to attach these at the next stage, but please see below comments on additional uploads. Please do not include information containing customer personal information unless you have secured appropriate consents.
- 2) The second relates to the **guidance you are seeking**, specifically: "Please describe what guidance you are seeking from the Innovation Enquiry Service. By setting out what particular questions you have we can respond to your enquiry faster. If you are unsure about some of your questions, just note this and explain what you want to know broadly."
- a) We are looking to understand what you want us to help you with. We appreciate that some users will have a very clear question in mind, and others may be less certain. Here are two examples of an equally valid responses about the above hypothetical company:

We are seeking guidance on whether we are obliged to obtain a retailer authorisation from the Australian Energy Regulator, and whether we are eligible for any exemptions from such a requirement. We are also seeking guidance as to whether any further licences or authorisations would be required if we were to branch out into selling/leasing batteries. We have already successfully obtained our development approvals and have a good understanding of our safety obligations but want to check we haven't missed anything.

or

We are unsure of what next steps are. We understand we might need to apply for licences to be able to sell to customers but need help to understand what these are and how to go about that.
 - b) In both the above examples, it is clear what assistance we will need to provide. While the first response shows a higher regulatory understanding (and a better grasp of what regulations they might have to contend with), the second is still sufficiently clear for us to provide a response. **It is important to note though** that a clear, narrow question such as the first example may receive a response faster than the less clear question.
 - c) **We strongly recommend** that all users ensure they have gone to the Website and used the resources (particularly the [Regulation Navigator](#) and [Use Cases](#)) to find out what obligations may apply. This will likely either give you the information you need to ask a simpler question or may even provide you with a full response on the spot so you don't need to wait.
- 3) The third relates to **specific regulatory concerns** you may have, specifically: "Are there particular parts of the regulatory framework you are seeking guidance on? If you have specific regulatory questions or there are broader areas of regulation that you need help with, list them here. If you already know of any issues we can do more to ensure these are responded to specifically."

- a) This is not a mandatory field, so if you don't have any specific concerns you can leave this blank.
 - b) If, however, you do have concerns about any specific regulatory obligations, you should note these here so we know what to focus on.
- 4) The fourth and final question relates to how your **innovation will help consumers**.
- a) Energy is an essential service which people depend upon for their health and wellbeing. As such it is important that consumers are protected in their energy dealings.
 - b) All energy innovations should consider how their business model or proposal will positively or negatively impact consumers.
 - c) If the IES receives high demand and prioritisation criteria are implemented, enquiries which evidence strong consumer benefits may be prioritised over enquiries which do not.
 - d) Consumer benefits can include (but of course aren't limited to) cheaper energy, improved service delivery, increased reliability, increased market competition, and response to customer demands (e.g. customer demands for renewable energy or locally-produced energy). If you are claiming any of these (or other) benefits apply, you should set out **how** they apply.

Providing supporting files may be helpful in limited circumstances but should not generally be relied upon. **Examples of a helpful supporting file** could include:

- 1) A diagram of a proposed generation plant highlighting how energy will be developed and transported to either the network or to specific premises.
- 2) A copy of advice previously received about the project from which your questions are derived.
- 3) A short (less than 5 pages) business proposal setting out specific plans and consumer models.

Examples of unsuitable supporting files include:

- 1) Marketing material.
- 2) Long (greater than 5 pages) documents not directly relevant to the regulatory question at hand.
- 3) Material duplicating the information you have provided elsewhere in the application.

Uploaded files should only be used where absolutely necessary; instead, users should rely upon the text boxes provided to note any relevant background. We are not able to review large quantities of material for any IES enquiry.



Provide evidence of the applicant's technical capacity to carry out the proposed trial project. This may include details of the skills and experience of key persons involved in the project and details of any third-party expertise that may have been leveraged.

Access to a Dispute resolution scheme (mandatory)

If applicable, provide evidence the applicant is already a member of the Energy and Water Ombudsman (Victoria) or has approached the Energy and Water Ombudsman (Victoria) about joining the scheme. If there is an alternative form of external dispute resolution proposed, then provide details of the alternative scheme.

Upload attachment

Statutory declaration (mandatory)

The applicant must declare that all information provided in the application for a trial waiver is true and correct. The applicant must provide an executed statutory declaration. The statutory declaration must be made by the applicant (where the applicant is an individual) or a director of the applicant (where the applicant is a corporation) and must be made in accordance with the requirements of the Oaths and Affirmations Act 2018 (Vic).

How to apply for a trial rule change

The Portal is **not currently** accepting trial rule change applications.

When Regulatory Sandboxing legislation passes, the AEMC will have a new power to assess trial rule change requests and make trial rules to allow trials to proceed. This could be used to temporarily amend existing rules or to temporarily introduce a new rule of limited application.

Trial rule change requests will be received through the Energy Innovation Toolkit, and will be forwarded to the AEMC for assessment. Where a trial requires both a trial rule change and trial waiver, the AEMC will work closely with the AER to craft trial rule change conditions.

Once this power is in force, this Guide will be updated with information about how to apply through the Portal for a trial rule change.
